# Part 1: SecurePass User Registration and Login Instructions for TLC

Step 1: Navigate to SecurePass.



# Part 2: SecurePass Instructions for Access to Health Benefits Direct and the TLC Renewal Data Sheet

Step 1: Complete "SecurePass User Registration" Steps 1-4 (above) to register your SecurePass account.

Step 2: Office of Health Benefits administrators will request and approve your application access to Health Benefits Direct. If you already have application access to Health Benefits Direct, skip to step 4.


- Once your SecurePass account is created, OHB administrators will complete the steps to request and approve your application access to Health Benefits Direct. Please allow 1-3 business days from the date you establish your SecurePass user account for this process to be completed by OHB. It is important to register as soon as possible to guarantee you will be granted application access to Health Benefits Direct prior to the deadline to submit your TLC Renewal Data Sheet.
- No action on your part is needed to request access to Health Benefits Direct in SecurePass. You do not need to notify OHB that your SecurePass account has been created.

Step 3: Wait for notification from <u>noreply@dhrm.virginia.gov</u> that your access to Health Benefits Direct has been granted.

• An email will be sent to the email address you used to register with SecurePass to notify you that your application access to Health Benefits Direct has been approved. Please remember to check your junk or spam folder for lost email from <a href="mailto:noreply@dhrm.virginia.gov">noreply@dhrm.virginia.gov</a>.
